
Sir,

Central Organisation will send draft govt. orders for empanelment of hospitals cleared by the screening committee and meeting the laid down criteria alongwith the minutes of the screening committee meeting to the Deptt. of ESW by 15th of ensuing month of issuing the govt. orders in consultation with MoD(Finance).
