**NOTIFICATION**

SRO 4) whereas a detailed Schemes for the administration of the Armed Forces Flag Day Fund was notified vide SRO 7 (E) dated 13 April, 1993 and 26<sup>th</sup> May, 2006 by Government of India, Ministry of Defence.

Whereas, Department of Ex-Servicemen Welfare headed by Secretary, ESW has been created in 2004 which, now, handles matters related to Armed Forces Flag Day Fund.

Whereas, the post of Additional Secretary, Ministry of Defence heading the then ESW Division has been upgraded to Secretary, ESW.

Whereas, Managing Director, Ex-Servicemen Contributory Health Scheme has been brought under the administrative control of Deptt. of Ex-Servicemen Welfare.

Whereas, Kendriya Sainik Board (KSB) Secretariat has been separated from Directorate General (Resettlement) in the year 2009.

And, whereas, there is unspent income on AFFD corpus accumulated over the previous years lying unspent.

Now, therefore, the Central Government in exercise of powers vested in it under section 5 of the Charitable Endowments Act, 1890 (6 of 1890), hereby makes the following amendments in the said notification:-
