## REIMBURSEMENT OF EXPENDITURE ON THE MAINTENANCE OF RAJYA/ZILA SAINIK BOARDS

Sir,

According to the existing procedure, 50% of the maintenance expenditure in respect of the Rjay/Zila Sainik Boards is reimbursed from Defence Service Estimates after scrutiny of the expenditure statements received from the states/UT Administration by the Kendriya Sainik Board.

- 2. In supersession of the above procedure, I am directed to convey the sanction of the President of India to the adoption of the enhanced funding pattern. This enhanced funding would be in the ration of 75:25 for 11 Special Category States viz Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Tripura, J&K, Himachal Pradesh, Uttarakhand & Sikkim and in the ration of 60:40 for the rest of the 21 States/UTs and these will be effective from 01<sup>st</sup> Oct 2010. The release of payment on account of Central Share after revised funding pattern will be the same i.e. 50% of the admissible Centre Share to be reimbursed at the stage of Budget Allocation as advance payment and balance 50% as final payment after the audit/booking of expenditure by the AG of the concerned State. As regard funding of construction of Sainik Rest House and Matching Grant, the existing procedure of sharing 50:50 by Centre and state will continue.
- 3. Kendriya Sainik Board will exercise the necessary administrative check over the estimates and expenditure statements rendered by the State Govt/Union Territory Administration before processing the claims. The payment in this regard will be made by the Area Accounts Office, Delhi Cantt, under PCDA(WC), Chandigarh.
- 4. The expenditure will be debitable to Major Head 2076, Minor head 800-B(s) of the Defence Services Estimates.
