



NATIONAL CONCLAVE FOR ESM ORGANISED BY DESW







SUCCESS STORIES: ENTREPRENUER ESM



SGT. DEEPAK (RETD)

After serving with honour and dedication for 20 years in the Indian Air Force, Sgt Deepak (Retd.) decided to channel his discipline and determination into entrepreneurship. Before retirement, through his peers, he learned about the various resettlement opportunities offered by the Directorate General Resettlement (DGR) for a second career. Initially interested in setting up a warehouse in his native district, he completed a Warehouse Supervisor Course at IED, Shimla, from 07 Apr 25 to 11 Jul 25. Coming from an agrarian background, he also developed a keen interest in livestock and allied sectors. To diversify his ventures, he underwent professional training in Fish Farming at the Fisheries Department, Hisar, Haryana. Leveraging this training, he established a modern aquaculture setup on his two-acre farmland, featuring Biofloc tanks and constructed ponds. He primarily cultivates Common Carp, Rohu, and Catla species.

Through his fish farming enterprise, Sgt Deepak is projected to earn an annual profit of ₹10-12 lakh. His initiative has also generated employment for local villagers, and he continues to adopt mechanized systems to enhance productivity and yield. Supported under the Pradhan Mantri Matsya Sampada Yojana, his venture stands as a model of successful rehabilitation and rural entrepreneurship. Sgt Deepak's journey embodies the true spirit of a soldier discipline, perseverance, and commitment proving that with proper planning, training, and determination, the transition from military service to self-reliance can be both smooth and inspiring.



CFN. HEMANTA KUMAR GOGOI (RETD)

CFN Hemanta Kumar Gogoi (Retd) who is 76% disabled, retired from Corps of EME on 31 Mar 2024 after completion of 20 Years of exemplary service as Avn Tech (Elect).

In month of Feb 2025, due to initiative of RSB Assam, he came to know regarding how to open a CSC Centre. Thereafter he was provided training at ZSWO Jorhat by CSC team free of cost at the initiative of DGR & DESW. He got his CSC registration in May 2025.

Inspite of his physical disability, he has opened a CSC Centre and has been assisting the ESM fraternity in various services available in CSC portal.

Supreme Court Directs Union To Grant Pension To Ex-IAF Officer Who Was Released After 15 Years As Short Service Commission Woman Officer: Key points

Supreme Court Directs Union To Grant Pension To Ex-IAF Officer Who Was Released After 15 Years As Short Service Commission Woman Officer The Court said that the Wing Commander Anupama Joshi was entitled to grant of pension computed from such date that she would have completed 20 years of service i.e. completion of 20 years of service.

Ilssue

Whether a Short Service Commission Woman Officer (SSCWO), who served 15 years in the Indian Air Force and was released before becoming eligible for pension, is entitled to pensionary benefits on parity with similarly placed officers post the Babita Puniya and Wg. Cdr. Tayyaba judgments.

Factual Background

• Wing Commander Anupama Joshi served as an SSCWO in the IAF for 15 years and was released before she could complete 20 years of qualifying service for pension. After the Supreme Court's landmark decision in Babita Puniya v. Union of India (2020), which granted permanent commission to SSC women officers, a follow-up ruling in Wg. Cdr. A.U. Tayyaba v. UoI (2023) held that such officers, even if released, could be deemed to have completed 20 years of service for pension purposes. Anupama Joshi had also been a petitioner in Babita Puniya, but was released before the verdict and had declined the offer for permanent commission due to alternate employment.

Reasoning and Observations.

• The Supreme Court observed that denying pension to Anupama Joshi while granting it to others in similar circumstances would be discriminatory. Since she was part of the Babita Puniya litigation and similarly situated as Tayyaba, she was deemed eligible for pension. The Court held that completion of 15 years in service under the special scheme and being ineligible only due to timing should not disentitle her to benefits granted under judicial direction..

Conclusion

- The Court directed the Union of India to:
- Deem her to have completed 20 years of service, and
- Grant pension and all consequential benefits, with arrears, as extended to other similarly situated officers.

This ruling expands the benefit of pension to other former SSCWOs who were released after 14 or 15 years and may have missed out on permanent commission due to timing. It affirms the principle of equal treatment, further operationalizes Babita Puniya, and strengthens gender parity in the Armed Forces.

VISIT TO CHHATTISGARH BY SECRETARY KSB

Brig DS Basera, VSM**, Secretary KSB attended 6th Rajya Sainik Board meeting chaired by Hon'ble Chief Minister of Chhattisgarh, Shri Vishnu Deo Sai and discussed various welfare schemes for war widows, ex-servicemen and their dependents. During the meeting the following decision were taken by the State Govt:

- Increase of ex-gratia assistance from Rs 20 lakh to Rs 50 lakh from dependent relatives of soldiers martyred in war or military operations.
- Recipients of the Param Vir Chakra, the nation's highest wartime gallantry award, will now receive Rs 1 Crore, up from the previous Rs 40 lakh provided by the state.
- The Govt also decided to raise the motivational grant for parents of soldiers from Rs 5,000/- to Rs 20,000/- and for soldiers disabled in battle from Rs 10 lakh to Rs 30 lakh.
- Serving soldiers, ex-servicemen and widows will now receive stamp duty exemptions of upto Rs 25 lakh on their first land or house purchase.
